Sep 1 to Oct 31, 2016 Consumers who buy four Mickey Thompson Baja MTZ P3, Baja Claw TTC, or Deegan 38 tires will receive a \$100 Prepaid Card by mail, or consumers who buy four Mickey Thompson Classic III, Classic III Black, Classic Baja Lock, Sidebiter II, Deegan 38 Pro 2, Deegan 38 Pro 4, MM-164B, MM-164M, MM-245, MM-366, or MM-489 wheels will receive a \$75 Prepaid Card by mail. Here's how:

1. This offer is open to legal residents of the 50 United States, the District of Columbia, and Puerto Rico making purchases in participating retail stores in those locations. The mail-in offer is not transferable and is valid only for the individual who purchased four new qualifying Mickey Thompson tires and/or wheels in a single transaction for personal household use.
