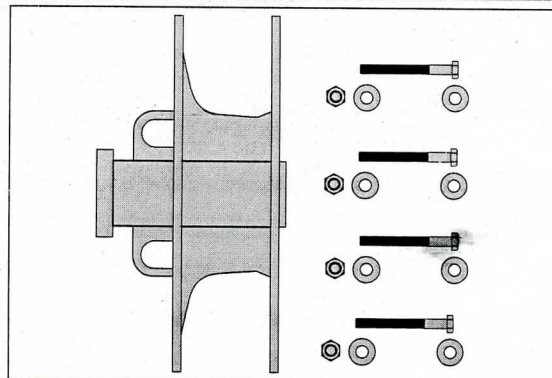

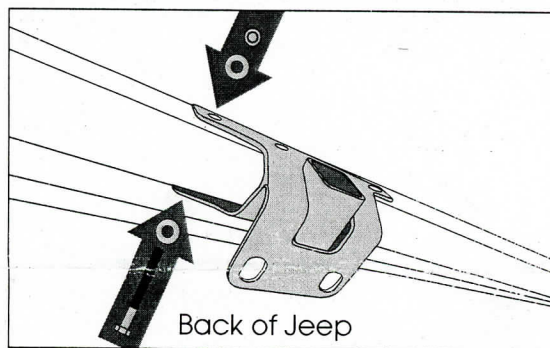

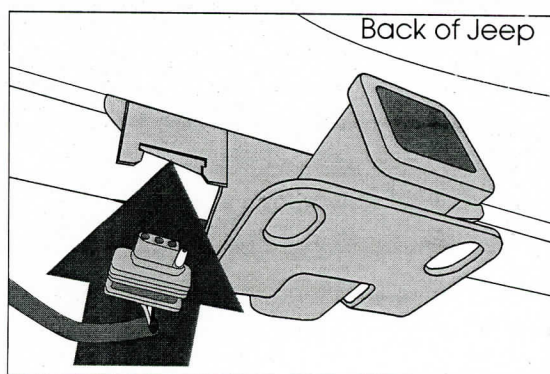


NOTE: If vehicle is equipped with a tow hook it must be removed before installation.

1. Slide receiver hitch over rear cross member. Insert bolts and washers, secure with washers and lock nuts. Secure lock nuts with 19 mm open end wrench; tighten bolts with 18 mm socket or wrench. Tighten bolts to 80 ft-lbs of torque.



2. Insert trailer wiring, if equipped, into the trailer wiring mounting tab. Installation is now complete.
